KEY OPERATING DATA OF 2022 FIRST QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2022 first quarter of the Company and its subsidiaries (collectively, the “**Group**”).

NEW ENERGY BUSINESS SEGMENT

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2022 first quarter amounted to 3,962,151.76 MWh, representing an increase of 1.08% over the corresponding period of 2021; the on-grid power generation amounted to 3,870,667.94 MWh, representing an increase of 1.11% over the corresponding period of 2021. As of 31 March 2022, the accumulated power generation amounted to 3,962,151.76MWh, representing an increase of 1.08% over the corresponding period of 2021; the accumulated on-grid power generation amounted to 3,870,667.94MWh, representing an increase of 1.11% over the corresponding period of 2021. From January to March 2022, the average on-grid tariff (tax exclusive) of the Group was RMB0.45/ KWh, representing a decrease of 5.63% over the corresponding period of 2021; the Group’s transacted electricity volume in the electricity market amounted to 687,999.40 MWh, the proportion of transacted electricity volume in the electricity market amounted to 17.77%, representing an increase of 8.26 percentage points over the corresponding period of 2021.
