**KEY OPERATING DATA OF NOVEMBER 2022**

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for November 2022 amounted to 1,239,479.58 MWh, representing a year-on-year decrease of 15.43%. As at 30 November 2022, the accumulated power generation amounted to 12,493,523.40 MWh, representing a year-on-year increase of 3.83%.

According to the Company's preliminary statistics, the transmission volume of gas of the Group on a consolidated basis for November 2022 amounted to 299,137,200 cubic meters, representing a decrease of 14.19% over the corresponding period of 2021, of which, the sales volume of gas amounted to 247,875,500 cubic meters, representing a decrease of 20.28% over the corresponding period of 2021; the volume of gas transported by the Group for its client amounted to 51,261,600 cubic meters, representing an increase of 36.00% over the corresponding period of 2021. As at 30 November 2022, the accumulated transmission volume of gas amounted to 3,708,469,000 cubic meters, representing an increase of 5.97% over the corresponding period of 2021, of which, sales volume of gas amounted to 3,237,770,700 cubic meters, representing an increase of 0.47% over the corresponding period of 2021, the volume of gas transported by the Group for its client amounted to 470,698,300 cubic meters, representing an increase of 70.01% over the corresponding period of 2021.
