OPERATING DATA OF 2017 SECOND QUARTER

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited* (the “**Company**”) announced that, according to the Company’s preliminary statistics, total generation power of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2017 second quarter amounted to 1,680,766.43MWh, representing an increase of 46.10% over the corresponding period in 2016. Among which, the gross wind power generation was 1,655,774.25MWh, representing an increase of 45.91% over the corresponding period in 2016. The solar power generation was 24,992.19MWh, representing an increase of 59.67% over the corresponding period in 2016. The sales volume of gas of the Group on a consolidated basis for the 2017 second quarter amounted to 310,494,100 cubic meters, representing an increase of 75.82% over the corresponding period in 2016. Among which, the wholesale segment amounted to 129,898,600 cubic meters, representing an increase of 12.68%; the retail segment amounted to 163,377,000 cubic meters, representing an increase of 278.86%; and the CNG/LNG segment amounted to 17,218,400 cubic meters, representing a decrease of 5.40%.

Details of the gross power generation and the sales volume of gas of the Group for the six months ended 30 June 2017 and 2016 are as follow:
