OPERATING DATA OF 2017 THIRD QUARTER

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) is pleased to announce that, according to the Company’s preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2017 third quarter amounted to 1,140,594.75MWh, representing an increase of 144.13% over the corresponding period of 2016, comprising (1) the gross wind power generation of 1,109,967.34MWh, representing an increase of 147.28% over the corresponding period of 2016 and (2) the solar power generation of 30,627.41MWh, representing an increase of 67.10% over the corresponding period of 2016. The sales volume of gas of the Group on a consolidated basis for the 2017 third quarter amounted to 337,239,300 cubic meters, representing an increase of 108.29% over the corresponding period of 2016, comprising (1) the wholesale segment of 161,447,100 cubic meters, representing an increase of 54.08% over the corresponding period of 2016, (2) the retail segment of 154,740,400 cubic meters, representing an increase of 271.30% over the corresponding period of 2016, and (3) the CNG/LNG segment of 21,051,800 cubic meters, representing an increase of 36.22% over the corresponding period of 2016.

Details of the gross power generation and the sales volume of gas of the Group for the nine months ended 30 September 2017 and 2016 are as follow:
