OPERATING DATA OF 2018 SECOND QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) announced that, according to the Company’s preliminary statistics, total power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for the 2018 second quarter amounted to 1,729,793.89MWh, representing an increase of 2.92% over the corresponding period in 2017. In particular, the gross wind power generation was 1,694,706.83MWh, representing an increase of 2.35% over the corresponding period in 2017; the solar power generation was 35,087.06MWh, representing an increase of 40.39% over the corresponding period in 2017. The sales volume of gas of the Group on a consolidated basis for the 2018 second quarter amounted to 428,246,400 cubic meters, representing an increase of 37.92% over the corresponding period in 2017. In particular, the wholesale segment amounted to 197,129,100 cubic meters, representing an increase of 51.76% over the corresponding period in 2017; the retail segment amounted to 212,467,900 cubic meters, representing an increase of 30.05% over the corresponding period in 2017; and the CNG/LNG segment amounted to 18,649,400 cubic meters, representing an increase of 8.31% over the corresponding period in 2017.

Details of the gross power generation and the sales volume of gas of the Group for the six months ended 30 June 2018 and 2017 are as follow:
